Some members expressed their frustration with how spots are given in WRSL and gave examples (U13G Dorchester and Oakridge, with one spot on WRSL left empty from EMSA, U14 two teams played off, team that won play offs got spot but other team was 1st in EMDSL). Also wondered why no district clubs in other districts (ie: Kitchener) Other members mentioned that they understand that the district needs to follow OS Policy

John D

Currently motion before OS that academies play in same stream as clubs. Decision may be made on this end of month. May have two OPDL groups, those spots may go to those groups. District has to follow OS, it is not team movement it is player movement. Moving forward we can provide club info about what EMSA has to implement from OS. Similar Policy from OS when it pertains to scores and standings, district must follow our governing bodies policy

Explained the past programs that the district has done in the past. Explained why some districts don't have district clubs, that those districts have one club.

ITEM #2

SPORTSENGINE (SE)

\$3.10 collected by clubs, it is a user fee not a registration fee

End of October meeting with DPF with what is going to happen with the registration system. EMSA district not invoicing clubs the user fee of SE. The contract between OS with SE coming to the end of its 5 year term. As a district we will be asked at the October District President's Form if our members want to continue with SE or not. Several members had left, so difficult to get a true sense of what the members wanted
