## **Youth to Senior Affiliation Agreement**

Between Organizations operating Youth Amateur Teams and Senior Amateur Teams

**Intent:** To allow organizations operating Youth Amateur Teams to affiliate with an organization only operating Senior Amateur Teams in order to allow players from the Youth Amateur Team to **play up** to the Senior Amateur Team in **league games only**.

## This Agreement is subject to the following Terms:

- 1. This Agreement is subject to the OSA's League Operational Procedure 9.1 Procedure 20.0
- 2. This Affiliation Agreement must be signed by two organizations affiliated with the same District Association under which they agree to "play up" players from a youth team to a senior team of the other organization into a league game.
- 3. Any game of the player's youth team shall take precedence over any game of the senior team.
- 4. With permission of both organizations in the Affiliation Agreement, a youth player may play up in a league game of any senior team with which the organization has an affiliation agreement.
- 5. The individual player(s) will not register or sign an agreement with the organization they are to "play up" to.
- 6. Any Senior League may impose limitations on such movement, provided that the limitations are applied consistently.
- 7. A youth player who is also registered as a senior player for an organization outside of the affiliation agreement is not permitted to play up to the organization within the affiliation agreement under these provisions.
- 8. An organization operating youth amateur teams may enter into an affiliation agreement with:
  - a) Only one organization that operates both Women's and Men's team; or
  - b) Only one organization which operates Women's teams only; and/or
  - c) Only one organization which operates Men's teams only
- 9. An organization operating senior amateur teams may enter into an affiliation agreement with:
  - a) Only one organization that operates both Girl's and Boy's teams; or
  - b) Only one organization which operates Girl's teams only; and/or
  - c) Only one organization which operates Boy's teams only
- 10. In a District where there is only one organization operating competitive youth teams, that organization may enter into an affiliation agreement with any number of organizations operating Men's and Women's team in that District.
- 11. The "Youth to Senior Affiliation Agreement" must be approved and filed with the following organizations in order to be in effect:
  - a) The Ontario Soccer Association
  - b) the District Association with which the two Organizations are affiliated
  - c) The League in which the "playing up" will be occurring
