

Dear EMSA Tier III Team Managers:

The Province of Ontario has enacted Concussion Safety legislation throughout its sport system, which has a mandatory implementation for Outdoor 2020.

Each team manager must collect the following **PRIOR** to any player/team staff being allowed on the field.

The below applies to any player under the age of 26

### **PLAYERS**

#### **STEP 1**

Review Ontario's Concussion Awareness Resources, 2 options:

**After** reviewing, in either format, each player/parent or guardian must sign a "Receipt of Review of Concussion Awareness Resource"

Review and sign "Concussion Code of Conduct for Athletes & Parents/Guardians"

Please provide the signed- "Receipt of Review of Concussion Awareness Resource" and "Concussion Code of Conduct for Athletes & Parents/Guardians" to your team manager

The below applies to any Team Official (coach and managers)

### **TEAM OFFICIALS**

#### **STEP 1**

Review Ontario's Concussion Awareness Resources, 2 options:

**After** reviewing in either format each player/parent or guardian must "Receipt of Review of Concussion Awareness Resource"

#### **STEP 2**

Review and sign "Concussion Code of Conduct for Coaches and Team Staff"

#### **STEP 3**

Please provide the signed- "Receipt of Review of Concussion Awareness Resource" and "Concussion Code of Conduct for Coaches and Team Staff" to your team manager

**TEAM MANAGER**

Once you have collected ALL players and team staff's signed

- "Concussion Code of Conduct for Athletes & Parents/Guardians"
- Concussion Code of Conduct for Coaches and Team Staff"

Due to volume EMSA does request that you make a PDF for each of the above groups for each team (IE: PDF of all signed Receipt of Review" for one team, 2<sup>nd</sup> PDF of all signed Code of Conduct for Athletes of one team, 3<sup>rd</sup> PDF of Code of Conduct for Team Staff of one team)
